## Documents we received at meeting

'Flood Hazard Applicability Determination Flood Hazard Control Act N.J.A.C 7:13-1.1 et Seq.' Determination Sept 16, 2016

Summary: DEP determined that a Flood Hazard Area Permit is not required for the pipeline.

## Action:

- 1. Encourage twp attorneys to litigate against the Permit by Rule' PBR
- 2. Encourage EPA to investigate fitness of NJ DEP with their latest ruling as far as Horizontal Directional Drilling.

State Agriculture Development Committee, Review of Non-Agricultural Development Project in an Agricultural Development Area. Resolution FY2016R4(6) Amended Sept 22, 2016

**Summary:** The Ocean & Monmouth County ADB found the SRL would not cause adverse effects. Monmouth County indicated that block 53 is open space and they granted NJNG temporary use for the project. Burlington County found project would cause adverse effects and they did receive a NJNG response, which removed a valve site on block 1000 lot 1 in Chesterfield. But added 4 temporary work areas along the route. Then Burlington County CADB staff determined that the pipeline project is acceptable. The State Agricultural Development Commission (SADC) approved SRL.

Summary: Map of NJ Acid Producing Soil. High Acidity in proposed SRL compressor station area and

pipeline area.

**Action:** Educate yourself on this, the soil in Compressor Station/Pipeline area is Acid Producing, Pipeline and Compressor Station infrastructure is more likely to age and fail unless extra protection is provided and caution is taken. When exposed, oxidation and hydrolysis of the sulfide minerals can produce the damaging sulfuric acid with pHs as low as 2.5, and can damage surrounding infrastructure at accelerated

rates.

Status of Litigation against the BPU

There are 7 appeals arising from the BPU's action, plaintiffs (Bordentown Twp, Chesterfield Twp, Sierra Club, Burlington County) requested consolidation of appeals, which only have to do with NJNG.

-NJNG does not have to abide by safety- 2 litigants

-NJNG does not have to abide by municipal land use laws-5 litigants
